

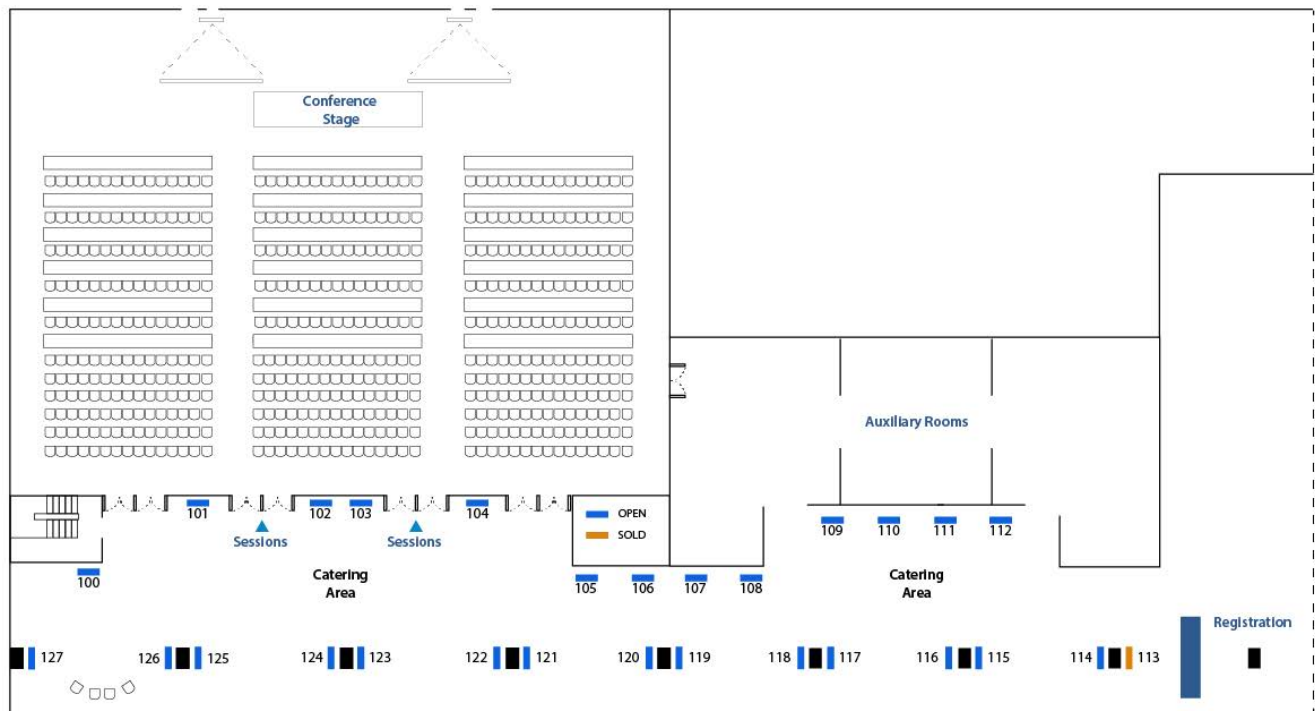


Exhibition Opportunities
